VOLUNTEER IMPACT





51 ADVOCATES - 102 CHILDREN SERVED



Our volunteers logged over 3,000 hours on their cases last year, seeing their kiddos each week and gathering information.



CASA submitted over one hundred Court Reports advocating for services and permanency for children are submitted to the Judge each year.



CASAs are required to complete 12 hours of continuing education each year. In 2023, our volunteers completed 470 hours of additional training to help better serve their kiddos.



11 new volunteers went through one of our two 30-hour initial trainings and were sworn in by Judge Haakenson.





TRANSLATING DOLLARS INTO ADVOCACY

RECRUIT:

We advertise the need for volunteer advocates through billboards, bus and radio ads, and sending staff to community outreach events. The screening process to ensure quality volunteers is extensive.

TRAIN:

Staff conducts quality training for volunteers to equip them with the skills and information necessary to perform their role. Staff facilitates ongoing training for advocates throughout the year.

SUPERVISE:

Specialized staff is required to supervise over 50 advocates. We provide guidance, emotional support, and ongoing assistance in navigating the complexities of the child welfare system.
